Sydney Markets Limited is strongly committed to protecting your privacy while interacting with our content, products and services. We want to provide a safe and secure environment for everyone.

Like many organisations, Sydney Markets Limited must comply with the National Privacy Principles contained in the Privacy Act in dealing with personal information.

Privacy and Security In Cyberspace

This policy applies only to websites operated by Sydney Markets Limited.

The Sydney Markets Limited website allows you to choose what kind and how much information you provide to us and to control how we use whatever information you give us. Our goal is to provide you with a satisfying experience while allowing you to control your privacy and to give you a means to voice any questions or concerns you may have.

The only way we know something about you personally is if you provide it to us.

There are however some parts of the Sydney Markets Limited website that do ask you to enter personally identifiable information. If you choose not to register or enter personally identifiable information, you can still use most of the website functionality.

The personal information collected by the Sydney Markets website is not on-sold to any third party. As a matter of policy, Sydney Markets Limited does not engage in mass e-mailing.

Accessing your information

If Sydney Markets Limited holds your personal information then Sydney Markets Limited will where possible provide you with access to the information. Sydney Markets Limited will take reasonable steps to correct information that you inform us is not accurate, complete or up to date.

Where practical, Sydney Markets Limited will ensure the removal of personally identifiable information at your request. If we refuse your request to access, amend or delete your personal information, we will provide you with a reason for our decision and, in the case of amendment, we will note with your personal information that you have disputed its accuracy. Cookies and Log Data

Cookies are information files which your web browser places on your computer when you visit a website. Most major web sites use cookies to provide useful features for their visitors and such use has become an industry standard. You can deliberately disable cookies should you wish by checking the appropriate part of your browser preferences or options menus, however you may then not be able to take full advantage of some of the features on the Sydney Markets website.

Log data traffic is information collected by the Sydney Markets Limited web server, which hosts the Sydney Markets website. It exists to tell us things like how many visitors we have, how long they stay for each visit, where they go when they're here at the Sydney Markets website and what kind of browser and operating system they have. This information is important because we can continually improve the Sydney Markets website as a result. The information is highly secure and only accessible to Sydney Markets Limited. The information it gives us is only ever used in aggregate form.
