



# SAFETY NOTICE

## Friday Changeover Period/Growers Market to Paddy's Friday

This Safety Notice has been prepared as a result of an Improvement Notice which has been posted around Building D. It is important that all stakeholders (including without limitation tenants, contractors and forklift operators) be aware that SafeWork NSW is very interested in forklift activity and traffic management at Sydney Markets.

To assist SML in the continuation of improving safety within the Sydney Markets site, all forklifts exiting and entering Building D from 9.00am to 10.00am on Fridays, will only be permitted to use the doorways on the northern side of Building D.

The following information is provided to assist stakeholders during the Friday Growers Market into Paddy's Friday changeover period.

- Forklift operators must exit through the northern side of Building D from 9.00am to 10.00am on Fridays. T Bollards and red and white barrier tape will be placed at doorways, on the southern side of Building D, to prevent forklift access.
- Forklift operators must exercise caution at all times whilst operating a forklift on the Sydney Markets site and drive to conditions.
- "Shortcuts" are not appropriate nor are they permitted through the southern side of Building D from 9.00am to 10.00am on Fridays.
- When travelling along the roadways/doorways, forklift operators must be aware of pedestrians at all times.
- Forklifts must be operated at a safe speed at all times (the speed limit is 10kph in covered areas on the Market site) and forklift operators need to remember to drive to conditions.
- Slow down on wet and slippery surfaces and at cross walkways or locations where vision is obstructed.
- Forklift operators entering or exiting a building or nearing a blind corner, must make their approach at reduced speed and proceed cautiously.
- RMS Road Rules must be adhered to at all times.

Further improvements will be made following the continuation of safety within the Sydney Markets site.

SML would like to remind all stakeholders that they have a WHS responsibility and obligation to their workers and visitors of the Market. This includes a requirement to have Safe Work Practices in place when operating a forklift within Building D and attending Building D as a pedestrian.


